

PET POLICY

Welcome to The Draftsman Hotel! We are pleased to offer a “Home Away From Home” for your pet(s) during your stay with us. We look forward to providing a memorable stay for you and your pet. Please read the following conditions of our pet policy and indicate your understanding and agreement by your signature. If you have any questions concerning this policy, please let us know.

This policy applies to all and any pets, regardless of size or species. Refusal to sign this policy does not release any registered guest from charges under this pet policy.

PET FEE

I understand that the pet policy for The Draftsman Hotel is as follows:

A \$75.00 Non-Refundable Cleaning Fee will be charged to your account prior to checking out to cover any additional and necessary cleaning in preparation for our next guest. If room fumigation is required due to pest infestation, an additional fee over and above the cleaning fee may apply. _____ - Guest Initials

PET CONDITIONS

We welcome all well-mannered dogs and cats to our property. We reserve the right to require immediate removal of any pet that displays dangerous or unacceptable behavior, including, but not limited to, biting, excessive noise (such as barking), evidence of disease or urination/defecation in public areas. No more than two (2) pets may occupy a guestroom. Each guest is responsible for all charges that relate to the removal of his/her pet, including but not limited to transportation and kennel charges. If we receive noise complaints about your pet, we will attempt to contact you to resolve the issue. If we are unable to contact you, we will reserve the right to house your pet in a kennel, at your expense.

Your pet is allowed in all areas of the hotel, with the exception of public areas where food and beverages are served or consumed.

I also understand that I am responsible for the daily maintenance, cleaning and the care of my pet(s) during my stay. I will also be considerate of other guests by walking my pet(s) around the hotel property; complying with the City of Charlottesville Leash Law* “Under Charlottesville City Code § 4-38, it is unlawful for the owner of any dog to allow the dog to “run at large, at any time, within the city.” However, if the dog is sterilized and “within the immediate voice control of its owner,” the dog is not considered to be “at large.” So, the owner does not need to keep the dog leashed. (Still, in certain areas such as city parks and along the greenway trail system, the owner must keep the dog leashed regardless of whether it is sterilized and within the owner’s immediate voice control.)” and keeping my pet(s) from making excessive noise.

(Service animals are not considered pets and guests traveling with them are not required to complete this form. This stipulation does not apply to “emotional support animals, comfort animals, or therapy pets.”)

For the safety and comfort of your pet, housekeeping/maintenance will only enter the room if:

- Your pet(s) are not present
- You are present and you can monitor your pet(s)
- Your pet(s) are in their cage

Your hotel account will be charged for any and all repair or replacement cost for damage done by your pet(s).

The guest agrees to release, defend and indemnify The Draftsman Hotel, Marriott International, Inc., and Donohoe Hospitality from any and all claims or damages related to your pet(s) or your pet’s stay at The Draftsman Hotel, including any claims by third parties.
